GIST OF THE COMPLAINT:

The complainant consumer The President, Nandigaon II P P, Repr. By Sri Gualu Sunani, AT- Nandigaon. P.O- Ghantiguda Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt.24.01.2024, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Irrigation supply with CD of 9.5 KW having consumer no. **9060-0102-0436** under EE NED, Nuapada.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (EE NED, Nuapada) in its counter reply and course of hearing submitted as follows:



- 1) PVR
- 2) Bill details from January 2020 to February 2022
- 3) Date of supply: 24.01.2020
- 4) Category: LT/ Irrigation
- 5) Connected Load: 9.5 KW
- 6) Meter No- 10041541
- 7) Installed on: 10.08.2023 with IMR: "0"
- 8) CMR: NA as on 09.02.2024
- 9) Facts of the complainant: Revision of bill
- 10) As written version submitted by EE NED, Nuapada as follows:
 - The provisional/average bill was served from 01/2020 to 12/2023.
 - The power supply has disconnected since long.
 - As per billing database the meter was changed on Dtd. 10.08.2023, but as per physical verification report of MRT on dtd. 09.02.2024 there is no meter found at site.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that the provisional/average bill was served from 01/2020 to 12/2023. And the power supply has disconnected since long.
- As per billing database the meter was changed on Dtd. 10.08.2023, but as per physical verification report of MRT on dtd. 09.02.2024 there is no meter found at site.

ORDER 30.03.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To install a new meter in the premises of complainant and reconnect the power supply after obtaining requisite reconnection fees.
- To revise the bill from 03/2022 to 02/2024 by taking one-year average consumption of new meter.
- ➤ The complainant is directed to pay the bill as decided by the licensee as per regulation 144 of OERC Distribution (Conditions of Supply) Code, 2019.

The case is disposed of accordingly.



Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
