

# GIST OF THE COMPLANT:

The Complainant Sri Harikesh Jal (Prop. M/s Jal Brother Poultry Farm) appeared before the Forum during the camp court held at Nuapada on dt. 07/11/2023 for abnormal billing done of 66804 units amounting to Rs 111353.78 in the month of August-2023 against the poultry farm owned by him before installation of a new meter on date 11/09/2023.

# SUBMISSION OF COMPLAINANT DURING HEARING:

The complainant reiterated his complaint regarding abnormal billing done amounting to Rs 111353.78 against the poultry farm owned by him in the month of 08/2023 before installation of new meter on date 11/09/2023. He requested to withdraw the abnormal bill and to revise as per the consumption pattern of the presently installed meter.

# SUBMISSION OF OPPOSITE PARTY DURING HEARING:

The OP (JFM F&C NED Nuapada) has submitted the following documents:

- a) A written Statement, stated that:
  - The date of power supply is 25/02/2019.
  - > Category is HT Allied Agriculture Activities.
  - Connected load is 70 KW.

- Meter Number is TWH20183 with CMR 265.72 KWH.
- > The consumer was billed on provisional basis from April-2022 to July 2
- Consumer was billed during Aug-23 for 66804units for Rs 111353.78.

 b) PVR Dtd. 08/01/2024 was submitted mentioning CMR as "265.79" Kwh and meter status 'OK'.

## **OBSERVATIONS OF THE FORUM**

From the database and statement as submitted by JFM (F&C), NED, the Forum observed that absurd billing was done with 66804 units in the month of August-2023, which is neither based on FMR of old meter nor the consumption of the new meter for the month of August-2023. Old meter, having SI. No. WEG0526, was defective and not recording the consumption from the date of installation i.e. 26/04/2022 to the date of replacement i.e. 11/09/2023.The consumer has also cleared all EC bills up to July-2023 served to him. So, the bill with 66804 units served to the consumer in the month of August-2023 seems to be illogical. The consumer was also aggrieved for such high bill served to him in a single month. So, the absurd bill needs to be revised.

ORDER 30.01.2024

Based on the above observations, the Forum passes the following order as per regulations 155 of OERC Distribution (Conditions of Supply) Code 2019. Direction of the Forum:

To revise the bill for the month of August-2023 taking six months average consumption of the present meter installed on 11/09/2023.

Case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
