GIST OF THE COMPLAINT:

The complainant consumer Sri Sallim Mahammad, Repr. by Sri Sheik Sakil, AT-Gadramunda, Po- Chindaguda, Ps- Khariar, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 25.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.50 KW having consumer no- 9061-2102-0507 under SDO Elect. Khariar.
- 2) As complained by the complainant that the provisional/average bill was served during the period from 07/2015 to 12/2019.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 29/07/2024
- 2) Bill details from March 2001 to June 2024
- 3) Date of supply 01/01/1990



- 4) Category: LT/Domestic
- 5) Connected Load 1.50 KW
- 6) Meter No LW506057
- 7) Installed on 01/01/2020 with IMR: "0"
- 8) CMR: 2026 KwH as on 29/07/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Khariar as follows:
 - The consumer complaining about the high amount of billing during the period of construction of house from January 2018 to January 2022.
 - The consumption load is very low whereas bill is being served in provisional basic due to defective meter for the period from 01/2018 to 12/2019 and later on during the month of January 2020 a new meter is install.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the consumer complaining about the high amount of billing during the period of construction of house from 01/2018 to 01/2022.
- The consumption load is very low whereas bill is being served in provisional basic due to defective meter for the period from 01/2018 to 12/2019 and later during the month of 01/2020 a new meter is install.

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 01/2018 to 12/2019 by taking six months average consumption of present IMR "0" KwH on 01/2020 and FMR "12" KwH on 06/2020.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
