GIST OF THE COMPLAINT:

The complainant consumer Sri Nua Thela Repr. by Lakshyapati Thela, At- Khairbhadi, PO- Tukla, Ps- Khariar Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 21.03.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ DOM supply with CD of 0.5 kw having consumer No. **9061-2103-0784** under SDO Elect. Khariar.
- 2) As complained by the complainant the provisional bill was raised from 04/2018 to 10/2019 prior to electrification date.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the provisional bill was raised prior to electrification date.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar.) in its counter reply and course of hearing submitted as follows:

- 2) Billing Abstract from April 2018 to March 2024
- 3) Date of supply 29/04/20108
- 4) Category: LT/ DOM



- 5) Connected Load 0.5 KW
- 6) Meter No- WLT191079
- 7) Installed on: 12/11/2019 with IMR: "1"
- 8) CMR: 1357 Kwh as on 07/04/2024
- 9) Meter Status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Khariar. as follows:
 - The consumer bill was wrongly generated without service connection from 29.04.2018 under SOUBHAGYA SCHEME to till installation of meter on 12.11.2019.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for withdraw the provisional bill was raised prior to electrification date. The OP submitted that the consumer bill was wrongly generated without service connection from 29.04.2018 under SOUBHAGYA SCHEME to till installation of meter on 12.11.2019, so the bill may be withdrawn 04/2018 to 10/2019.

ORDER
14.05.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

- To withdraw the bill from 04/2018 to 10/2019, as the provisional bill was raised prior to the date of power supply.

The case is disposed of accordingly.
