GIST OF THE COMPLAINT:

The complainant consumer Sri Barna Bag, At- Khairbhadi, PO- Tukla, Ps- Khariar Dist-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 21.03.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ DOM supply with CD of 0.5 kw having consumer No **9061-2103-0829** under SDO Elect. Khariar.
- 2) As complained by the complainant the provisional bill was raised from 04/2018 to 07/2019 prior to electrification date.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the provisional bill was raised prior to electrification date.

• The consumer bill was wrongly generated without service connection from 29.04.2018 under SOUBHAGYA SCHEME to till installation of meter on 02.08.2019.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

• The complainant reiterated for excess billing. The OP stated that the consumer bill was wrongly generated without service connection from 29.04.2018 under SOUBHAGYA SCHEME to till installation of meter on 03.08.2019, so the bill may be withdrawn 04/2018 to 07/2019.

ORDER 14.05.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.:

> To withdraw the bill from 04/2018 to 07/2019, as the provisional bill was raised prior to the date of power supply.

The case is disposed of accordingly.
