### GIST OF THE COMPLAINT:

The complainant consumer Sri Budu Meher, C/O-General Maneger, District Industrial Center Office, At/PO- Khariar Rossa, Dist-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 07.02.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ GP supply with CD of 2.5 KW having consumer No **9061-2110-0532** under SDO Elect. Khariar.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.
- 3) As complained by the complainant the provisional/average bill was served during various period.

The complainant has prayed for:

To revise the provisional/average bill.

# SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar.) in its counter reply and course of hearing submitted as follows:

11) As written version submitted by SDO Elect. Khariar as follows:

 The average bill was served to consumer from 03/2001 to 11/2003, 09/2013 to 12/2014 & 12/2015 to 11/2017.

 As PVR submitted by AoC, Khariar-I, during the site verification it is found that consumer using meter no is- WLT7099875 and the CMR is 384 KwH on dtd. 15.04.2024 and the meter has found OK.

The consumer has not availed the power supply.

## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

• The complainant reiterated for revise of his average billing. The OP submitted that the average bill was served to consumer from 03/2001 to 11/2003, 09/2013 to 12/2014 & 12/2015 to 11/2017.

### ORDER 22.04,2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To Revise the bill from 12/2015 to 11/2017 by taking six-month average consumption of the meter was installed on 12/2017 (i.e. IMR "0" KwH on 12/2017 and FMR "76" on 05/2018).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
