GIST OF THE COMPLAINT:

The complainant consumer Sri Trilochan Dandasena, Repr. By Sri Israr Dandasena, At-Chandel, Po-Tukla, Ps-Khariar, Dist.-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 07.02.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ DOM supply with CD of 1 KW having consumer No **9061-2117-0003** under SDO Elect. Khariar.
- 2) As complained by the complainant the average bill was raised during his disconnection period from 05/2010 to 03/2018.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To withdraw the average bill was raised from 05/2010 to 03/2018 during disconnection period.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar.) in its counter reply and course of hearing submitted as follows:

 - As per joint verification conducted by the Lineman-A, AoC Khariar-I & ESO-I, Khariar
 on dt. 19.04.2024 and discussion with Sarpanch, Duhelpada & neighbour of the
 consumer and found that the statement of the consumer is correct.
 - The S/C is reconnected during 03/2018.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for withdraw of average billing was raised during disconnection period from 05/2010 to 03/2018. The OP submitted that the consumer is declared as ghost during (5th phase ghost consumer identified out of bill stop/PDC consumer dt.28.09.2023)
- The consumer has paid Rs. 32,023.00, vide MR No. 65754409022420200001 dtd. 09.02.2024.
- As per joint verification conducted by the Lineman-A, AoC Khariar-I & ESO-I, Khariar on dt. 19.04.2024 and discussion with Sarpanch, Duhelpada & neighbour of the consumer and found that the statement of the consumer is correct.
- The S/C is reconnected during 03/2018.

ORDER 22.04.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To withdraw the bill from 05/2010 to 02/2018 only fix charge to claim for the period.
- To install a new meter in the consumer premises in coordination with MRT, and restore the power supply with immediate effect.
