GIST OF THE COMPLAINT:

The complainant consumer Sri Pyaris Behera, At- Bankapur, Po- Khasbahal, Ps- Khariar, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 25.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.50 KW having consumer no- 9061-2118-0523 under SDO Elect. Khariar.
- 2) As complained by the complainant that the provisional/average bill was served from 11/2020 to 04/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 29/07/2024
- 2) Bill details from November 2020 to June 2024
- 3) Date of supply 01/11/2020
- 4) Category: LT/Domestic



- 5) Connected Load 0.50 KW
- 6) Meter No 300048745
- 7) Installed on 20/03/2023 with IMR: "0"
- 8) CMR: 1008 KwH as on 29/07/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Khariar as follows:
 - The bill during the month of 11/2022 at 1644 units is seems to be suppress reading case may be revise from the date of installation of the old meter (30/10/2020) vide meter no. 284016 (old) for slab benefit of the consumer.
 - The defective period bill from 12/22 to 1/23 prior to installation of new meter may be revise as per six-moth normal consumption of new metre install on 20/03/2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The bill during the month of 11/2022 at 1644 units is seems to be suppress reading case may be revise from the date of installation of the old meter (30/10/2020) vide meter no. 284016 (old) for slab benefit of the consumer.
- The defective period bill from 12/22 to 1/230 prior to installation of new meter may be revise as per six-moth normal consumption of new metre install on 20/03/2023.
- As per billing database the bill for the period of 02/23 to 04/2023 was revised towards delay meter updating on dtd. 12/06/2023. And amount of Rs. 3623.89 was withdrawn.

ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 11/2020 to 11/2022 with IMR "0" KwH on 11/2020 and FMR "2244" KwH on 11/2022.
- To revise the bill from 12/2022 to 04/2023 by taking six-moth average consumption of present meter (i.e. IMR "0" KwH on 03/2023 and FMR "600" KwH on 08/2023).
- To withdraw the earlier bill revision was effect on dtd.12.06.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
