

GIST OF THE COMPLAINT:

The complainant consumer Sri Bhoro Majhi, At/Po-Birighat, Ps-Duajhor, Dist.-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 23.07.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.50 KW having consumer no- 9061-3219-0100 under SDO Elect. Khariar.
- 2) As complained by the complainant abnormal bill was served in the month of 11/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from: 02/2015 to 06/2025
- 3) Date of supply: 01.08.2014
- 4) Category: LT/Domestic
- 5) Connected Load: 0.50 KW
- 6) Meter No TWSP51013286
- 7) Installed on: 09.09.2023 with IMR "0"
- 8) CMR: 2739 Dt. 30.07.2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Khariar as follows:
 - As per observation in asserted that the aforementioned consumer defective meter is being replaced with the new meter vide meter no. TWSP51013286 on dt.09.09.2023 the average consumption of defective period of bill from 04/2016 to 11/2022. However, the respondent requested the forum to take appropriate decision as necessary.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per observation in asserted that the aforementioned consumer defective meter is being replaced with the new meter vide meter no. TWSP1013386 on dt.09.09.2023 the average consumption of defective period of bill from 04/2016 to 11/2022.
- From 02/2015 to 11/20222 Provisional/Average bills have been served.
- Meter No. TWSP51013286 had been installed on dt. 09.09.2023 and the CMR is "2739" KwH as on dt. 30.07.2025.
- There is no scope for revision of bill.

ORDER 31.07.2025
