GIST OF THE COMPLAINT:

The complainant consumer Sri Ujal Rana, Repr. by Sri Muna Rana, AT/Po- Mandosil, Ps- Khariar, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 25.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9061-3306-0124 under SDO Elect. Khariar.
- 2) As complained by the complainant the abnormal bill was raised during the period from 04/2005 to 08/2009.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:

 - The consumer complaining about high amount of bill during the month of May 2009 to august 200% @26892.06 per month.
 - As per observation due to punching of run meter reading with meter no. 1973158A provisional bill were generated @26892.06. per month which was treated rectify at 1324 units ("0" code reading rectification) during the month of august 2009.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the consumer complaining about high amount of bill during the month of May 2009 to august 2009 @26892.06 per month.
- As per observation due to punching of run meter reading with meter no. 1973158 A provisional bill were generated @26892.06 per month which is treated rectify at 1324 units ("0" code reading rectification) during the month of august 2009.

ORDER

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill by way of recasting from 04/2005 to 08/2009 with IMR "0" KwH on 04/2005 and FMR "1324" KwH on August 2009.

The case is disposed of accordingly.
