GIST OF THE COMPLAINT:

The complainant consumer Sri Motiram Rout, Repr. by Sri Hemanta Bhoi, At- Dotto, Po- Karangamal, Ps- Boden, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Boden on dt. 23.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no-9061-3311-0047 under SDO Elect. Khariar.
- 2) As complained by the complainant that 1574 units was served in the month of 04/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 28/10/2024
- 2) Bill details from: 02/2009 to 09/2024
- 3) Date of supply: 13/12/2008
- 4) Category: LT/Domestic



- 5) Connected Load 1 KW
- 6) Meter No TWST17362121
- 7) Installed on: 04/06/2024 with IMR: "0"
- 8) CMR: 226 KwH as on 28/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Khariar as follows:
 - The consumer complaining about high meter reading taken with the meter no-LW282743 during the month of 04/2023 at 2680 unit billed for 1574 unit may be recast date of installation of meter from 10/2019 to 04/2023 for slab benefit to the consumer.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the consumer complaining about high meter reading taken with the meter no- LW282743 during the month of 04/2023 on 1574 units.
- As per billing database bill was raised in the month of 04/2023 with high consumption of 1574 units, which seems supress meter reading.

ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 10/2019 to 04/2023 with IMR "0" KwH on 10/2019 and FMR "2680" KwH on 04/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
