GIST OF THE COMPLAINT:

The complainant consumer Sri Dambarudhar Majhi, AT- Sunapur, P.O- Sunapur, Dist-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Boden on dt. 14.12.2023 in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Dom supply with CD of 0.25 KW having consumer No. 9061-3312-0595 under SDO Elect. Khariar.
- The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect.Khariar) in its counter reply and course of hearing submitted as follows:

- 1) PVR
- 2) Billing Abstract from : October 2019 to November 2023
- 3) Date of supply: 10.08.2019
- 4) Category: LT/ Domestic



- 5) Connected Load: 0.25 KW
- 6) Meter No- TW02091677
- 7) Installed on: 31.10.2023
- 8) CMR: 199 KWH as on 01.01.2024
- 9) Facts: Suppress units billed in the month of April 2023 and meter defective in July 7/2023.
- 10) As per written version submitted by SDO Khariar as follows:
 - Supress units of 2127 units billed in the month of April-2023.
 - Abnormal reading of 583 units billed in July-2023.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that supress reading was billed during April 2023 and meter was defective during 7/2023.
- But as per billing data base the supress reading was bill in the month of April 2023

 the abnormal bill was served in July 2023. And meter found defective from July-2023 to October-2023.

ORDER 01.02.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill by way of recasting from 10/2019 to 04/2023 with IMR "0" on 10/2019 and FMR "3037" on 04/2023.
- ➤ To revise the bill for the month of July-2023 to October-2023 by taking six months average consumption of new meter installed on 31.10.2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
