GIST OF THE COMPLAINT:

The complainant consumer Sri Sahadev Majhi, AT-Redhamal .P.O- Bhaisapali Dist-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Boden on dtd. 14.12.2023 in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Dom supply with CD of 0.40 KW having consumer No 9061-3314-0020 under SDO Elect. Khariar.
- 2) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:

- 9) Facts: Excess units billed during 12/2022 of 1033 units and subsequently provisional/ average billed has served.
- 10) As per written version submitted by SDO Khariar as follows:
 - The consumer has been billed for 1033 units during the month of 12/2022. Subsequently bill was served average basis.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

The complainant reiterated for provisional / excess billing. The OP submitted that the consumer has been billed for 1033 units during the month of 12/2022. Subsequently bill was served average basis.

ORDER 01.02.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 12/2022 to 12/2023 by taking six-month average consumption of new meter has installed on 07.01.2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
