### GIST OF THE COMPLAINT:

The complainant consumer Sri Shojaneswar Singh Mallik, AT- Bireshkela, Po/Ps-Boden, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 19.06.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestive supply with CD of 1 KW having consumer no- 9061-3318-0046 under SDO Elect. Khariar.
- 2) As complained by the complainant the abnormal bill was raised from 09/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the abnormal/excess bill.

#### SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 25/06/2024
- 2) Bill details from March 2001 to June 2024
- 3) Date of supply 01/01/1990
- 4) Category: LT/Domestic



- 5) Connected Load 1 KW
- 6) Meter No TWST1736711
- 7) Installed on 20/06/2024 with IMR: "0"
- 8) CMR: 36 Kwh as on 25/06/2024
- 9) The meter status OK
- 10) Facts of the complainant: Revision of abnormal bill
- 11) As written version submitted by SDO Elect. Khariar as follows:
  - The consumer is complaining about the excess unit bill in comparison to his used load. After proper verification and testing done by MMG it is found that meter is defective with error of 28.12%. Old defective meter (Meter no. WLT221638) has been replaced with new smart meter (meter no. TWST1736711) on dt-20/06/2024.

#### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

• The complainant reiterated for excess billing. The OP submitted that the consumer is complaining about the excess unit bill in comparison to his used load. After proper verification and testing done by MMG it is found that meter is defective with error of 28.12%. Old defective meter (Meter no. WLT221638) has been replaced with new smart meter (meter no. TWST1736711) on dt-20/06/2024.

## ORDER 31.07.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 09/2021 to 05/2024 by taking six-months average consumption of new meter install on 20/06/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
