GIST OF THE COMPLAINT:

The complainant consumer Sri Laxmikanta Meher, At/Po- Sinapali, Ps- Sinapali, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Sinapali on dt. 19.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9061-3402-0149 under SDO Elect. Khariar
- 2) As complained by the complainant that no supply was in my house due to demolition.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

As per consumer version he is not availed the power supply due to demolished of his old house during the period of 01/2019 to 06/2021 may be revise/withdrawal as per field report attached here with for reference.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that as per consumer version he is not availed the power supply due to demolished of his old house during the period of 01/2019 to 06/2021 may be revise/withdrawal as per field report attached here with for reference.
- The consumer has intimated to SDO Khariar that he was not availed the power supply from 06/2019 to 07/2021 due to demolition of old house which was signed in the application by neighbour consumers as witness.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To withdraw the bill from 01/2019 to 06/2021 excluding fixed charges as the consumer was not avail the power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 the opposite party after compliance otherwise it will be treated as non-compliance.
