GIST OF THE COMPLAINT:

The complainant consumer Sri Balev Meher, At/Po-Sinapali, Ps- Sinapali, Dist-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Sinapali on dt. 26.09.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 2 KW having consumer no-9061-3402-0829 under SDO Elect. Khariar.
- 2) As complain by the complainant that average bill was raised from 03/2018 to 09/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that Bill revision required for defective period of bill with meter no- 1265610 from 03/2018 to
- As per billing database the bill revision towards delay meter updating was take in place for the period from 09/2021 to 02/2022.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill from 09/2019 to 08/2021 by taking average consumption of present meter (i.e. IMR "241" KwH on 03/2022 and FMR "698" KwH on 08/2022).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
