GIST OF THE COMPLAINT:

The complainant consumer Sri S S Domb, Repr. by Sat. Kanaka bag, At- Sagunbhadi, Po-Chatiaguda, Ps- Sinapali, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar on dt. 21.11.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9061-3405-0156 under SDO Elect. Khariar
- 2) As complained by the complainant that abnormal excess bills were served in the month of 11/2021.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:

- Defective period of bill from 09/2014 to 09/2019 may be revise as per actual 6 months average reading with new meter for slab benefit to the consumer.
- Suppress unit taken during the month of 11/2021 at FMR 2231 unit billed for 1238 unit may be recast from date of supply of meter vide mete no-LW332052.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that defective period of bill from 09/2014 to 09/2019 may be revise as per actual 6 months average reading with new meter for slab benefit to the consumer.
- Suppress unit taken during the month of 11/2021 at FMR 2231 unit billed for 1238 unit may be recast from date of supply of meter vide mete no-LW332052.
- The energy bill have not served in actual meter reading in the meter. It was 1238
 unit billed for the month of 11/2021, which seems to be suppressed meter reading.

ORDER

30.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- ➤ To recast the bill from 10/2019 to 01/2022 by taking IMR "0" KWH on 10/2019 and FMR "2299" KWH on 01/2022.
- To revise the bill from 10/2017 to 09/2019 by taking IMR "0" KWH on 10/2019 and FMR "479" KWH on 05/2020.

The case is disposed of accordingly.
