GIST OF THE COMPLAINT:

The complainant consumer Sri Pruthiraj Majhi, At- Kandamunda, Po- Jharbandh, Ps-Sinapali, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Sinapali on dt. 26.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.25 KW having consumer no-9061-3406-1154 under SDO Elect.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

The complainant reiterated for excess billing. The OP submitted that the consumer complaining high meter reading with the meter no- A2020145 during the month of 08/2023 at 2580 unit billed for 1427 unit seems to be suppress meter reading.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 01/2022 to 08/2023 with IMR "758" KwH on 01/2022 and FMR "2580" KwH on 08/2023.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
