GIST OF THE COMPLAINT:

The complainant consumer Sri Ramsaran Meher, At/Po- Hatibandha, Ps- Sinapali, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Sinapali on dt. 26.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no-9061-3418-0258 under SDO Elect. Khariar.
- 2) As complain by the complainant Rs. 28113.59 has serve for the month of 09/2021 which is very abnormal, so this may be considered.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:

2) Bill details from: 01/2002 to 09/2024

3) Date of supply: 10/10/2001



4) Category: LT/Domestic

5) Connected Load 1 KW

6) Meter No - TWNX506078

7) Installed on: 08/12/2023 with IMR: "0"8) CMR: 1636 KwH as on 09/10/2024

9) The meter status: Ok

10) Facts of the complainant: Revision of bill

11) As written version submitted by SDO Elect. Khariar as follows:

• Bill revision required from 05/12/2020 to 11/06/2022 at 8096 unit with meter no-LW684908 due to random billing (The revision for delay meter updating for the period of 05/12/2020 to 27/12/2021 may be reverse for settlement of suppress unit and random billing with meter no-LW684908) and defective period of bill from 07/2022 to 11/2023 may be revise as per the actual meter reading with new meter installed on dt-08/12/2023 for slab benefit to the consumer.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Bill revision required from 05/12/2020 to 11/06/2022 at 8096 unit with meter no-LW684908 due to random billing (The revision for delay meter updating for the period of 05/12/2020 to 27/12/2021 may be reverse for settlement of suppress unit and random billing with meter no-LW684908) to extend slab benefit to the consumer and defective period of bill from 07/2022 to 11/2023 may be revise as per the actual meter reading with new meter installed on dt-08/12/2023.

ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 12/2020 to 05/2022 by taking IMR "0" KWH on 12/2020 and FMR "8096" KWH on 05/2022.
- ➤ To revise the bill from 06/2022 to 11/2023 by taking six-month average consumption of new meter install on 08/12/2023 with IMR "0" KWH on 12/20323 and FMR "840" KWH on 05/2024.
- TO withdraw the earlier bill revision effect on date -31/01/2022 for the period from 01/2021 to 11/2021.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
