GIST OF THE COMPLAINT:

The complainant consumer Smt. Padukabedi Sahu repr. by Sri Santosh Kumar Sahu, At- Baigapada, Po- Chatiguda, Ps- Sinapali, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Sinapali on dt. 26.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.04 KW having consumer no-**9061-3421-0130** under SDO Elect. Khariar.
- 2) As complain by the complainant that the provisional/average bill was served most of the period from 08/2014 to 09/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:

- 2) Bill details from 11/2014 to 09/2024
- 3) Date of supply 22/08/2014
- 4) Category: LT/Domestic



- 5) Connected Load 0.04 KW
- 6) Meter No – TWSP51045847
- 7) Installed on 05/09/2023 with IMR: "0"
- 8) CMR: 614 Kwh as on 09/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Khariar as follows:
 - The consumer complaining high meter reading with the meter no- 6508534 during the month of 07/2021 at 2570 unit billed for 2278 unit seems to be suppress unit may be revise from the date of installation of old meter 22/08/2014.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP submitted that the consumer complaining high meter reading with the meter no- 6508534 during the month of 07/2021 at 2570 unit billed for 2278 unit seems to be suppress unit may be revise from the date of installation of old meter 22/08/2014.
- As per billing database the bill revision towards defective period assessment and delay meter updating was take in place for the period from 03/2017 to 11/2019, 01/2020 to 01/2022 & 12/2022 to 08/2013, effected on dtd.24.05.2024, 20.02.2022 & 14.03.2024 respectively.

ORDER

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- As the bill was already revised for the various periods. So, the bill no need to further revision.

The case is disposed of accordingly. Case is dropped.
