# **GIST OF THE COMPLAINT:**

The complainant consumer Sri Purandar Meher, At/Po- Sinapali, Ps- Sinapali, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Sinapali on dt. 19.03.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.05 KW having consumer no- 9061-3426-0675 under SDO Elect. Khariar
- 2) As complained by the complainant that there was no supply to my house prior to installation of meter.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

The OP (SDO Elect. Khariar) in its counter reply and course of hearing submitted as follows:



11) As written version submitted by SDO Elect. Khariar as follows:

- <u>Scope-1</u> As per consumer version supply was not given from date of supply as mention
  in database (Dt-15.05.2019). The electricity supply was availed by him from the date
  of installation of meter and servise connection on Dt-28.11.2023 with the meter NoTWSP51088297. The bill may be revise/withdrawal prior to actual date of service as
  per the PVR submitted by ESO Sinapali.
- <u>Scope-2</u> The meter No-TWSP51088297 installed on Dt-28.11.2023 whereas taken in to database on Dt.06.03.2024 so, bill may be revised from the date of installation of meter Dt-28.11.2023 at IMR "0" unit to FMR "489" unit as on 06.04.2024 for slab benefit to the consumer and resolve the issue of <u>Scop-1</u>

# FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that <u>Scope-1</u> As per consumer version supply was not given from date of supply as mention in database (Dt-15.05.2019). The electricity supply was availed by him from the date of installation of meter and servise connection on Dt-28.11.2023 with the meter No-TWSP51088297. The bill may be revise/withdrawal prior to actual date of service as per the PVR submitted by ESO Sinapali.
- <u>Scope-2</u> The meter No-TWSP51088297 installed on Dt-28.11.2023 whereas taken in to database on Dt.06.03.2024 so, bill may be revised from the date of installation of meter Dt-28.11.2023 at IMR "0" unit to FMR "489" unit as on 06.04.2024 for slab benefit to the consumer and resolve the issue of <u>Scop-1</u>
- As per billing database provisional bills were issued during 04/2023 to 06/2023

# ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

➤ To withdraw the bill from 05/2019 to 06/2023 as the consumer was not availing the power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>April-25</u> the opposite party after compliance otherwise it will be treated as non-compliance.
