GIST OF THE COMPLAINT:

The complainant consumer Sri Madhu Chelak, AT- Haldi, Po- Dumerpani, Ps/Dist-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 17.12.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1 KW having consumer no- 9062-3105-1620 under SDO Elect. Nuapada
- 2) As complained by the complainant that abnormal excess bill was served in the month of May 2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

The OP (SDO Elect. Nuapada) in its counter reply and course of hearing submitted as follows:

11) As written version submitted by SDO Elect. Nuapada as follows:

The bill is to be revise for the month of 05/2024 by taking the actual consumption for last six month of presently install meter.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the bill is to be revise for the month of 05/2024 by taking the actual consumption for last six month of presently install meter.
- It is seen from database that consumer was served with average/provisional bills from date of supply to 04/2024 mentioning without meter.
- As per billing database abnormal bill of 5381 units was served in the month of 05/2024 & DPS was levied from 10/2021 to 04/2023, which seems to be inapropriet.

ORDER 28.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To revise the bill for the month of 05/2024 by taking six months average consumption of present meter (i.e., IMR "0" KwH on 06/2024 and FMR "843" KwH on 11/2024).
- To withdraw the DPS amount from 10/2021 to 04/2023 as it is domestic category consumer.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by February-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
