GIST OF THE COMPLAINT:

The complainant consumer Sri Deepak Kumar Soni, Repr. by Sri Balram Soni, At/Po-Tanwat, Ps- Nuapada, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 24.10.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ General Purpose supply with CD of 0.50 KW having consumer no-9062-3106-5228 under SDO Elect. Nuapada.
- 2) As complained by the complainant excess bill amount was served in the month of 07/2024 which may kindly be considered.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Nuapada) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 30/10/2024
- 2) Bill details from: 11/2020 to 09/2024
- 3) Date of supply: 08/10/2020
- 4) Category: LT/Domestic



- 5) Connected Load 0.50 KW
- 6) Meter No TWST1736964
- 7) Installed on: 18/06/2024 with IMR: "0"
- 8) CMR: 13 KwH as on 30/10/2024
- 9) The meter status: Ok
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Nuapada as follows:
 - Bill has been served for 2750 unit to the consumer on dt. 30/08/2024 when current meter reading in only 13.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Bill has been served for 2750 unit to the consumer on dt. 30/08/2024 when current meter reading in only 13.
- Looking into the meter change report and billing database, if appear that a meter having SI No- 549687 was installed in consumer premisses from 11/2021 to till date of replacement i.e 18/06/2024, with a new meter having SI No- TWST1736964. During this period no reading was taken and bill were served on provisional basis.
- On the event of meter replacement final reading of old meter (Having SI no-549687) was submitted as 2734 and billed in the month of 07/2024. So, this units need to be spread over from 11/2021 to 07/2024 with proper adjustment of provisional bills to extend the tariff slab benefit to the consumer.

ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 11/2021 with iMR "0" KWH to 07/2024 with FMR "2734" KWH.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
