The complainant consumer Sri Kulas Rout repr. by Sukhiram Rout, At- Ratapali, P.O-Maulibhata, Ps- Nuapada Dist- Nuapada. under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at - Nuapada on dt. 25.04.24 in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Dom supply with CD of 0.40 KW having consumer No. **9062-3108-0233** under SDO Elect. Nuapada.
- 2) As complained by the complainant average bill was raised from 06/2016 to 09/2017.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:
To revise the average bill.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for average billing. The OP submitted that the average bill was served from period 06/2016 to 09/2017.

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To revise the bill from 06/2016 to 09/2017 by taking six month average consumption (i.e. IMR "0" Kwh on 10/2017 and FMR "118" Kwh on 03/2018.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
