#### **GIST OF THE COMPLAINT:**

The complainant consumer Smt. Jamunabai Patel, repr. by Sri Ramdhan Patel AT/Po- Sarabong, Ps- Nuapada, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 24.07.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.50 KW having consumer no- 9062-3108-1023 under SDO Elect. Nuapada.
- 2) As complained by the complainant the average/provisional bill was served though the meter was working.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

#### **SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Nuapada) in its counter reply and course of hearing submitted as follows:

- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Nuapada as follows:
  - The bill to be recasted for the period 07/2019 to 09/203 taking IMR "0" KwH and FMR "6157" KwH. Also, the bill for the period 10/2023 to 11/2023 taking the average consumption of the present meter.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing. The OP stated that the bill to be recasted for the period 07/2019 to 09/2023 taking IMR 0 and FMR 6157. Also, the bill for the period 10/2023 to 11/2023 taking the average consumption of the present meter.
- As per billing database bill revision was done for the period of 01/2020 to 01/2023 & 07/2020 to 09/2022, effect on dtd. 23.03.2023 & 11.11.2022 respectively.

## ORDER 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 07/2019 to 09/2023 with IMR "0" KwH on 07/2023 and FMR "6157" KwH on 09/2023.
- To revise the bill from 10/2023 to 11/2023 by taking six-month average consumption of present meter (i.e. IMR "0" KwH 12/2023 and FMR "428" on 01/2024.
- To withdraw the earlier bill revision was effect on dtd. 23.03.2023 & 11.11.2022.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
