### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Komal Lochan Naik, At- Tariamahuabhata, Po-Amana, Ps- Dharambandha, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 25.09.24, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 3 KW having consumer no- 9062-3111-0408 under SDO Elect. Nuapada.
- 2) As complained by the complainant that the provisional/average bill was served from 04/2015 to 05/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

## SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Nuapada) in its counter reply and course of hearing submitted as follows:

- 8) CMR: 458 KwH as on 01/10/2024
- 9) The meter status: Disconnected
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Nuapada as follows:
  - After meter charge wrong unit bill punched that is 12598 for the month of 05/2024 but the actual reading is 95 on dtd-10/05/2024.

# FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that After meter charge wrong unit bill punched that is 12598 for the month of 05/2024 but the actual reading is 95 on dtd-10/05/2024.
- As per billing database some bill was raised in high consumption reading from 04/2015 to 07/2023. And from 08/2023 to 05/2024 the bill was served in average basis.

# ORDER 28.10.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To recast the bill from 04/2015 to 07/2023 with IMR "0" KwH on 04/2015 and FMR "18141" KwH on 07/2023.
- To revise the bill from 08/2023 to 05/2024 by taking 6 months average consumption of present meter 29/05/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
