GIST OF THE COMPLAINT:

The complainant consumer Sri Sadananda Barik, Repr. By Sri Manoj Kumar Barik, At/Po-Komna, Via-Komna, Dist.-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 20.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9062-3202-0669 under SDO Elect. Nuapada.
- 2) As complained by the complainant that bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Nuapada) in its counter reply and course of hearing submitted as follows:

 - Defective period bill from 01/2022 to 12/2023 on average basis as per the billing data.
 However, the respondent requested the forum to take appropriate decision as necessary.



FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the Defective period bill from 01/2022 to 12/2023 on average basis as per the billing data.
- From 02/2019 to 12/2023 provisional / average bills have been served.

ORDER 10.09.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > The bills served from 01/2022 to 12/2023 (2 Year) are to be revised by taking IMR "0" KwH on 01/2024 and FMR "3949" KwH on 12/2024.
- To withdraw the earlier bill revision was effect on dt.28.07.2025.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by October-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
