GIST OF THE COMPLAINT:

The complainant consumer Sri Nabakishor Thakur, Repr. by Sri Sadhan Kumar Thakur, At- Ghotsar, Po- Kureswar, Ps- Komna, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 25.09.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 2 KW having consumer no- 9062-3207-0908 under SDO Elect. Nuapada.
- 2) As complained by the complainant the provisional bill has served though the meter was running and I have used the electricity in my house.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Nuapada) in its counter reply and course of hearing submitted as follows:

11) As written version submitted by SDO Elect. Nuapada as follows:

• Provisional bill generated from 06/2021 to 05/2023. Which is higher as compare to actual meter reading. Also change the tariff from 08/2024 from general purpose to domestic purpose.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Provisional bill generated from 06/2021 to 05/2023. Which is higher as compare to actual meter reading. Also change the tariff from 08/2024 from general purpose to domestic purpose.

ORDER 07.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 09/2017 to 07/2024 by taking IMR "0" KWH on 09/2017 and FMR "460" KWH on 07/2024.
- > To change the category general purpose to domestic with effect from 08/2024 as the consumer is availing power supply for domestic purpose. He has to deposit the appropriate amount towards security deposit.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by the opposite party after compliance otherwise it will be treated as non-compliance.
