### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Birabara Bhoi, Repr. by Sri Ashok Bhoi, At- Kumutimunda, Po- Jagrahi, Ps- Komna, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 18.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.04 KW having consumer no- 9062-3211-1312 under SDO Elect. Nuapada.
- 2) As complained by the complainant that the provisional/average bill was served during disconnection period since 2016 to 07/2023.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

The connection was dismantled since 2016 but bill served in provisional / LF basis. So, the billed amount from since 2016 is to be withdrawn.

### FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the connection was dismantled since 2016 but bill served in provisional / LF basis. So, the billed amount from since 2016 is to be withdrawn.
- As per billing database the provisional bill was served from 09/2015 to 07/2023. The sarapanch Jadamunda GP and neighbour consumer have intimated that the consumer has not availing the power supply since 2016 due to damage of house.

## **ORDER** 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To withdraw the bill from 01/2016 to 07/2023 as the complainant was not availing the power supply.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
