GIST OF THE COMPLAINT:

The complainant consumer Sri Sashibhusan Hati, AT- Kalimati, Po- Nuagaon, Ps- Komna Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 17.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 0.50 KW having consumer no- 9062-3301-0111 under SDO Elect. Nuapada.
- 2) As complained by the complainant that abnormal bill was raised in the month of 03/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Nuapada) in its counter reply and course of hearing submitted as follows:

11) As written version submitted by SDO Elect. Nuapada as follows:

 The consumption of the meter is to be re-casted from the date of installation of meter i.e. 18/03/2024.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the consumption of the meter is to be re-casted from the date of installation of meter i.e. 18/03/2024.
- As per billing database a new meter was changed on dtd.18.03.2024, whereas the abnormal bill was generated of 1571 units and 375 units in the month of 03/2024 and 04/2024 respectively.

ORDER 28.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To revise the bill from 03/2024 & 04/2024 by taking 6 months average consumption of present meter (i.e. IMR "1940" KwH in 05/2024 and FMR "3186" KwH in 10/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
