**GIST OF THE COMPLAINT:**

The complainant consumer Sri Musru Majhi, At-Jatagarh (Sineripada), Po-Jatagarh Via-Tarbod, Dist.-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 19.11.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- **9062-3313-0321** under SDO Elect. Nuapada.
- 2) As complained by the complainant that bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

**SUBMISSION OF OPPOSITE PARTY IN BRIEF:**

The OP (SDO Elect. Nuapada) in its counter reply and course of hearing submitted as follows:

- 4) Category: LT/Domestic
- 5) Connected Load: 1 KW
- 6) Meter No – TWST1735168
- 7) Installed on: 14.05.2024 with IMR "0"
- 8) CMR: 82 Kwh on Dt. 30.11.2025
- 9) The meter status: Regular
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Nuapada as follows:
  - The average bill of defective meter from 07/2016 to 10/2019 and suppressed reading bill for the month of 12/2022 as per billing data. However, the respondent requested the forum to take appropriate decision as necessary.



## FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that the average bill of defective meter from 07/2016 to 10/2019 and suppressed reading bill for the month of 12/2022 as per billing data.
- Bill revision towards delay updating was already take in place no further scope for bill revision.
