- The complainant has appeared before the forum for bill dispute of his LT/ Temporary Supply GP supply with CD of 1 KW having consumer no-9062-3316-0180 under SDO Elect. Nuapada
- 2) As complained by the complainant that to Change the billing tariff from LT/GP to to LT/ Domestic category from 06/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.


SUBMISSION OF OPPOSITE PARTY IN BRIEF:

 - The category of consumer has been changed as the same has been used for construction of a petrol pump. The supply of petrol pump was charged in the month of 09/2024. So, the category is to be changed and bill to be revised accordingly.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the category of consumer has been changed as the same has been used for construction of a petrol pump. The supply of petrol pump was charged in the month of 09/2024. So, the category is to be changed and bill to be revised accordingly.
- As per billing database the bill has served in LT/ GP tariff from 06/2024 to 03/2025, as the complainant has taken separate power supply for his commercial purpose and the above connection has used for domestic purpose.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To change the billing tariff immediately from LT/GP to LT/ Domestic category.
- To revise the bill from 06/2024 to 03/2025 in LT/Domestic tariff.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 by the opposite party after compliance otherwise it will be treated as non-compliance.
