GIST OF THE COMPLAINT:

The complainant consumer Smt. Mamata Nayak, Repr. by Sri Rabi Narayan Patra, At/Po-Kurumpuri, Ps- Lakhna, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 18.03.2025, in brief as follows:

- The complainant has appeared before the forum for bill dispute of his LT/ General Purpose supply with CD of 1 KW having consumer no-9062-3316-0308 under SDO Elect. Nuapada
- 2) As complained by the complainant that the power supply has used for residential purpose, but the bill has raised in LT/GP tariff instead of LT/Domestic tariff.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Nuapada) in its counter reply and course of hearing submitted as follows:

- 1) PVR: 02/04/2025
- 2) Bill details from: 08/2018 to 02/2025
- 3) Date of supply: 23/07/2018



- 5) Connected Load 1 KW
- Meter No WLT098089
- 7) Installed on: 23/07/2018 with IMR "0"
- 8) CMR: 3290 KWH on 02/04/2025
- 9) The meter status: OK
- 10) Facts of the complainant: Revision of bill
- 11) As written version submitted by SDO Elect. Nuapada as follows:
 - The premises is used by Smt. Mamata Kumari Nayak, ANM Kurumpuri since 08/2018 for resident purpose. but bill was wrongly generated in GP category so, bill is to be revised in domestic category instead of GP.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that the premises is used by Smt. Mamata Kumari Nayak, ANM Kurumpuri since 08/2018 for resident purpose, but bill was wrongly generated in GP category so, bill is to be revised in domestic category instead of GP.
- As per billing database the initial power supply tariff was LT/Domestic since 07/2018 to 02/2020. After that from 03/2020 to till date, the bill has served in LT/ GP tariff. As certified by the medical officer PHC, Tarbod, Dist- Nuapada, that Smt. Mamata Nayak has utilizing the power supply for domestic purpose at sub centre building since last august 2018.

ORDER 29.03.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To change the billing category from LT/GP to LT/ Domestic immediately.
- > To revise the bill from LT/ GP tariff to LT/ Domestic tariff since 03/2020 to 03/2025.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by April-25 by opposite party after compliance otherwise it will be treated as non-compliance.
