- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.


The complainant has prayed for:

# **FINDINGS / OBSERVATIONS OF THE FORUM**

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for provisional billing during no supply period.
- The OP submitted that as per billing data line disconnected/PDC from 11/2017 and there is no such record of disconnection.
- During discussion and subsequent clarification asked by this forum neither the complainant could able to provide any document asking disconnection of supply to discoms, nor SDO could able to provide document mentioning the date of disconnection of supply.
- With the above context, the forum observe that the bill raised up to Oct-2017 as per database, seems to be correct.

#### **ORDER**

## 31.08.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

As the bill stands final till 10/2017 and either the parties has not provide the documents regarding disconnection, so no need to revise the bill so consumer needs to clear the dues.
