- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 4.50 KW having consumer no- **9063-3101-0551** under SDO Elect. Khariar Road
- 2) As complained by the complainant excess bill was served in the month of May 2024 and October 2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

- As per billing database some bill was served in high consumption meter reading during the period from 11/2022 to 12/2024, which seems supress meter reading.
