#### **GIST OF THE COMPLAINT:**

The complainant consumer Sri Surjit Singh Saluja, Repr. by Sri Sonu Saluja, At/Po- Khariar Road Ward No-8, Ps- Khariar Road, Dist.- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 20.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/General Purpose supply with CD of 1 KW having consumer no- 9063-3102-0253 under SDO Elect. Khariar Road.
- 2) As complained by the complainant that the bill was served on provisional/average basis
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the provisional/average bill.

The OP stated that revision of old provisional bill.

As per billing database the provisional/average bill was served from 03/2002 to 02/2015.

## ORDER 30.11.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

To recast the bill from 03/2002 to 02/2015 with IMR "0" KwH on 03/2002 and FMR "6211" KwH on 02/2015.

The case is disposed of accordingly.
