GIST OF THE COMPLAINT:

The complainant consumer Sri Balbinder Singh, Repr. by Sri Harmit Singh Chawda, At-Guru Nanak Nagar, Ward- 11, Po- Khariar Road, Ps- Jonk, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Nuapada on dt. 20.11.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/ Domestic supply with CD of 1.50 KW having consumer no- 9063-3104-0131 under SDO Elect. Khariar Road.
- 2) As complained by the complainant that no supply present from 06/2008 to 12/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar Road) in its counter reply and course of hearing submitted as follows:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per PVR report submitted by ESO Khariar Road No-l section that during physical verification it was determine that no meter was found at site of above-mentioned consumer.
- As per billing database the provisional bill was served from 06/2008 to 11/2008 and average bill was served from 12/2008 to 10/2016 and power supply was disconnected from 11/2016 to 09/2021 and bill was stopped from 10/2021 to till date. And the complainant was paid last of Rs. 1000/- on dtd. 26.03.2014.

ORDER 28.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the bill from 11/2014 to 10/2016.
- > The complainant is directed to pay the balance outstanding arrear up to 03/2014 along with fixed charges and security deposit as applicable as per regulation of OERC (if wish to reconnect the same power supply to his premises).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>February-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
