GIST OF THE COMPLAINT:

The complainant consumer Sri Abdul Gaffar C/O President Muslim Jamad AT-Khariar Road Word No-1 (Patel Nagar), Po- Khariar Road, Ps- Jonk, Dist- Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar Road on dt. 18.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1.50 KW having consumer no- **9063-3107-0713** under SDO Elect. Khariar Road.
- 2) As complained by the complainant that the rented house was used for godown purpose previously
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:
To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar Road) in its counter reply and course of hearing submitted as follows:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP stated that Revised/withdraw the upward bill revision amount if possible.
- Sri Gopal Chandra Patnaik Lineman A has submitted a report that Abdul Gaffar has utilize the house as godown purpose from 04/2021 to 10/2022 which was certified by the JE No-I Khariar Road. The previous occupant has utilized the house for godown purpose but the present occupant has utilized the house for rented purpose its seems that the present consumer is using high consumption then the godown rented purpose.

ORDER

27.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- To withdraw the upward revision on prorated basis from 04/2021 to 10/2022. As the consumer has utilize the house for godown purpose.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by February-25 the opposite party after compliance otherwise it will be treated as non-compliance.
