GIST OF THE COMPLAINT:

The complainant consumer Sri Jagalsai Majhi, AT/Po- Mundapala, Ps- Lakhna, Dist-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar Road on dt. 18.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.5 KW having consumer no- 9063-3204-2593 under SDO Elect. Khariar Road.
- 2) As complained by the complainant that abnormal bill was raised in the month of 06/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

1) As written version submitted by SDO Elect. Khariar Road as follows:

 As per report of ESO, Khariar Road No.II section that the bill may revise as per meter reading.

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that as per report of ESO, Khariar Road No.II section that the bill may revise as per meter reading.
- As per billing database the current bill of the month of 05/2024 appears abnormal, as the bill unit claim is 61 units, but the current bill appears Rs. 2466.54.

ORDER 06.01.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

> To revise the bill as per actual meter reading basis (i.e. IMR "1198" KwH on 04/2024 and FMR "1259" KwH on 05/2024).

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by January-25 by the opposite party after compliance otherwise it will be treated as noncompliance.
