GIST OF THE COMPLAINT:

The complainant consumer Sri Milan Satnami, Repr. by Sri Tikeswar Satnami AT-Chingrasara, Po-Parkol, Ps-Beltukri, Dist-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar Road on dt. 18.12.24, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 0.29 KW having consumer no- 9063-3206-1107 under SDO Elect. Khariar Road.
- 2) As complained by the complainant that average bill was served from 06/2022 to 04/2024.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

SUBMISSION OF OPPOSITE PARTY IN BRIEF:

The OP (SDO Elect. Khariar Road) in its counter reply and course of hearing submitted as follows:

FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that High slab bill to be revise.
- As per billing database the bill was served in average basis from 06/2022 to 04/2024 due to meter defective.

ORDER 06.01.2024

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To restore the power supply immediately prior to obtain the reconnection fees as appropriate.
- To revise the bill from 06/2022 to 04/2024 by taking six-month average consumption of actual meter reading of meter installed on 21/05/2024.

The case is disposed of accordingly.

Compliance report must be submitted to the Forum by <u>January-25</u> by the opposite party after compliance otherwise it will be treated as non-compliance.
