GIST OF THE COMPLAINT:

The complainant consumer Sri Anup Majhi, At/Po-Jampani, Via- Khariar Road, Dist.-Nuapada under the territorial and statutory jurisdiction of respondent.

The complainant has appeared and submitted during course of hearing at camp court at Khariar Road on dt. 21.08.2025, in brief as follows:

- 1) The complainant has appeared before the forum for bill dispute of his LT/Domestic supply with CD of 1 KW having consumer no- 9063-3209-1170 under SDO Elect. Khariar Road.
- 2) As complained by the complainant that the bills to be revised.
- 3) The complainant has intimated the same to the OP, but till date the OP remains silent for which getting no other way the complainant has approached this forum for redressal of his grievance.

The complainant has prayed for:

To revise the excess bill.

 - Revise the high slab billing. However, the respondent requested the forum to take appropriate decision as necessary.



FINDINGS / OBSERVATIONS OF THE FORUM

On perusal of the complaint petition with all relevant enclosures as well as submission of OP and billing statement; the forum observes the followings:

- The complainant reiterated for excess billing.
- The OP submitted that revise the high slab billing.
- Some bill was served abnormally during the period from 08/2018 to 07/2025 due to supress meter reading.

ORDER 10.09.2025

Basing on above observations, the forum passes the following order as per regulations of OERC Distribution (Conditions of Supply) Code 2019.

The OP is directed as follows:

- > To recast the bill from 08/2018 to 07/2025 with IMR "0" KwH and FMR "1344" KwH.
- > Any bill revision done during the above period may be taken in to consideration.

The case is disposed of accordingly.
