## **GIST OF THE CASE**

The Complainant has filed the petition in the name of S.Sahu C/o Late Binod Kumar Sahu bearing Consumer No 4118-3408-0061 under SED, TPWODL, Sambalpur stated about billing dispute.

Hence, the Complainant prayed before the Forum to consider the case for revision/rectification.

## SUBMISSION OF OPPOSITE PARTY

The Opposite Party has submitted ledger for the period from Jun'2007 to May'2023, w/s dtd.12.07.2024 as well as enquiry report on 24.07.2024 and PVR dtd. 11.07.2024 in this case.

#### **OBSERVATION**

The case is pursued with all documents available in records (FG data base and Samadhan App) and merit of the case. On examining the case in details, the Forum observed that the complainant is a LTdomestic consumer having CD 2kw with initial date of p/s 29.06.2007 as seen from the FG data base/ Samadhan App. The complainant has raised objection on billing dispute since Mar'2008 as they were left their residence where found meter readings were going on even if no p/s and no use of power in that premises. In Mar'2008 actual bill has been served for kwh reading of 588 with billing unit of 288 having outstanding of Rs 629.27/-. Since, Apr'2008 PL/Avg. bills were going on @ different units (48/63/76/80/97/200/288/588 etc.) per month upto billing month May'2023 and subsequently declared as ghost consumer as seen from FG data base. During hearing dtd.11.06.2024 the complainant has claimed that the house was totally demolished when a Banayan tree fall on the house and whole family of the complainant shifted to quarter of Hirakud dam allotted to the father of the complainant Late Biond Ku. Sahu. After that the said house is remained in demolished condition till date. The p/s has remained disconnected since Jan'2008 and Rs 458/- has been paid on 15.10.2007 and Rs 52/- on 25.11.2007 with a request to disconnect but could not submit any relevant documents for approach of disconnection to opposite party. This Forum has gone through the PVR dtd.11.07.2024 as well as w/s on 12.07.2024 but not satisfied on the reporting of opposite party hence could not reach to the conclusion for order. During hearing dtd. 12.07.2024, this Forum has ordered to opposite party to conduct an enquiry in presence of the complainant and submit the report on or before 24.07.2024 and accordingly the opposite party have done the job and submitted the enquiry report on the stipulated time period. In enquiry report, the opposite party has clearly mentioned that there was no p/s available in that premises since 2008. This Forum has verified the billing data and found that actual bill has been served upto billing month Mar'2008 and considered it and concluded that the p/s was in effect upto billing month Mar'2008. But, it is seen that PL/Avg. bills were continuing since Mar'2008 to May'2023 might not be correct and has happened due to non-implementation of LTB-6 was in effect at that time for use in case of LD of p/s. Although, the complainant has not submitted the documents for approach of DC to opposite

party but during hearing it was convinced by this Forum which is confirmed later on followed by enquiry report submitted by opposite party. In such situation, the claim of the complainant to be consider as correct and the billing for the period from Apr'2008 to May'2023 to be withdrawn with declaring the consumer as PLD.

Hence, the Forum is in the opinion that the Opposite party is liable to revise the bill for the period from Apr'2008 to May'2023 by withdrawing all the billing and considering the consumer as PLD with effect from Apr'2008.

### **ORDER**

Considering the documents and statements submitted by both the parties at the time of hearing, the Forum hereby passes orders that:

- 1. The Opposite Party is directed to revise the bill of the consumer for the period from Apr'2008 to May'2023 by withdrawing all the billing and considering the consumer as PLD with effect from Apr'2008.
- Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
