GIST OF THE CASE

Bharti Jaiswal has appeared on Dt. 10.07.2024 at the camp held at SDO Office, Belpahar and submitted a written complaint wherein she has stated about billing dispute- high bill served during 2016-2019 on defective meter & requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted billing abstract from April-2007 to May-2024, a PVR carried on 11.07.2024 but no written statement has file in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 1KW with date of initial power supply 19.04.2007 through meter SI No 0325793A as seen from FG/Samadhan App. The complainant has raised objection on billing dispute- high bill served during 2016-2019 on defective meter with prayer to revise the bill. Meanwhile, the meter SI No 8140495 & LW15258 was installed /effected in billing in Feb-2013 & July 2019 (14.07.2019). The above complainant has been served PI/Avg bills for the period from April 2007 to July 2010 & Nov 2016 to June 2019. For correction of billing dispute revision is required for the above periods.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from April-2007 to Aug 2010 by taking IMR as 5 KWh in April 2007 & FMR as 239 KWh in Aug 2010 with reference to consumption recorded in meter SL No 0325793A & for the period from Nov 2016 to June 2019 by taking IMR as 1 in June 2019 & FMR as 114 on Dec 2019 with reference to consumption recorded in meter SL No LW15258 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased to pass the Order as follows.

1. The Opposite Party is directed to revise the bill for the periods from April-2007 to Aug 2010 by taking IMR as 5 KWh in April 2007 & FMR as 239 KWh in Aug 2010 with reference to consumption recorded in meter SL No 0325793A & for the period from Nov 2016 to June 2019 by taking IMR as 1 in June 2019 & FMR as 114 on Dec 2019 with reference to consumption recorded in meter SL No LW15258



with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law if any.

2. The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act,2003 under Section 56(i) and disconnect the power supply accordingly.
6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
7. **Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.**

Accordingly, the case is disposed of.
