GIST OF THE CASE

Premsila Patel has appeared on Dt. 15.07.2024 at the camp held at ESO Office, Panchgaon and submitted a written complaint wherein he has stated about billing dispute- Abnormal bill served on April 2024 for Rs.14029. for two month & requested to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted PVR carried on 16.07.2024 but no other documents except PVR has been submitted for this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD 0.15KW with date of initial power supply 08.11.2012 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute as mentioned in GIST with prayer to revise the bill. Meanwhile, the Meter Sl No LW446958 was installed 31.05.2021 with IMR 0 & MF 1. It is seen that actual bills were served to the complainant since installation of new meter except few Pl bills which have already been adjusted in billing on punching of actual reading. Although, actual billings were served with meter reading but it was not proper & correct due to table reading by meter readers & no verification by opposite party due to many of causes involved at that time. Actual bill for KWh reading of 5377 with billing unit 2411was raised in April 2024 where it is found that the KWh reading was 5500 on 16.07.2024 as per uploaded meter & its reading for which O-code has been seen & in June 2024 the IMR was 5500 KWh. The opposite party has levied Rs.7545.17 was defective period assessment from June 2019 to April 2021 in the billing of the complainant as well as revise the bill for the period from April 2024 to May 2024 (12.05.202 to 16.07.2024) & credited Rs. 3669.74. But this Forum doesn't agree on the revision & credit thereon, the supressed reading so billed in April 2024 relating to many periods during 31.05.2021 to 16.07.2024 & exactly can not be ascertain & the opposite party is also unable to explain the same. Hence, revision is required to settle the billing dispute.

Hence it is the opinion of the Forum that the opposite party is liable to revise the bill for the periods from 31.05.2021 to 16.07.2024 by spread over the reading of 5500 with IMR '0' in between the periods with reference to consumption recorded in meter SL No LW446958 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law.

ORDER

After careful consideration of hearing and data submitted by both parties the Forum is pleased Order as follows.

- 1. The Opposite Party is directed to revise the bill for the periods from 31.05.2021 to 16.07.2024 by spread over the reading of 5500 with IMR '0' in between the periods with reference to consumption recorded in meter SL No LW446958 with the daily/monthly actual consumption thereof considering the adjustment of previous bill revisions as per law.
- The Opposite party is directed not to consider the bill revision for the period already revised earlier/for the period of penalty/in both cases if any as applicable as not submitted any information for the same.
- 3. The Opposite party is directed not to consider the bill revision for the period already where the complainant has availed the OTS scheme and rebate thereon if any as applicable as not submitted any information for the same.
- 4. The Opposite Party is directed to serve the revised energy charges bill with revised due date within 30 days from the receipt of this Order, duly considering the applicable tariff during the period, taking in to account the adjustments, if any, and adjustment for the payments made by the complainant and ensure payment thereof.
- 5. The Opposite Party is directed to collect the revised bill amount and on non-payment, served the Disconnection Notice to the Complainant as per Indian Electricity Act, 2003 under Section 56(i) and disconnect the power supply accordingly.
- 6. The Complainant is directed to pay the revised billed amount so arrived, if any, within due date after receipt of the revised energy charges bill to avoid disconnection.
- 7. Opposite party is directed to submit the compliance report to this Forum within one month from the date of issue of this order as the case may be.

Accordingly, the case is disposed of.
