GIST OF THE CASE

Bijaya Dhal has appeared in the hearing on Dt. 09.08.2024 at the camp held at ESO Office, Naktideol and submitted a written complaint wherein he has stated that "after installation of new meter his electricity bill rate is high and he is getting high bills" & has request to revise/rectify the same.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted PVR carried out on Dt.09.08.2024 and consumer information sheet/WS in this case.

OBSERVATION

The case is pursued with all documents available in records submitted by the complainant and merit of the case. On examining the case in details, the Forum observed that the complainant is a LT-DOM consumer having CD of 0.5KW with date of initial power supply on Dt.27.06.2018 as seen from FG/Samadhan App. The complainant has raised objection on billing dispute with prayer to revise the bill. Meanwhile, the meter Sl No LW195400 which was installed on 03.10.2019 with IMR '0' & MF 1 whereas the meter bearing SL No TWB633540 was installed on 13.02.2024 with IMR '0' & MF 1. The KWh reading of meter SL No LW195400 was 9444 in Oct 2022 and the KWh reading was in that meter as 11775 in Aug 2023. Actual bills were served from Sept 2023 to Dec 2023 (12.02.2024) for KWh reading of 11783. In Oct 2022 the billing was served for Rs.58206.91 due to which arrear came to Rs.60832.91. It is also seen that bills were served for the period from date of power supply to 02.10.2019 on PL/Avg basis. However, the opposite party has already revised the bill for delayed meter updating and withdrawn an amount of Rs.15252.49 as well as revised the bill and also withdrawn Rs.38205.47 and further, revised the bill and debited Rs.24017.73. Sri Deepak Ku Sahu, officer RCM, TPWODLA has sent to verification of load and he has submitted the PVR along with photocopy of meter where the MD has been shown as 1.75KW on 09.07.2024 and monthly consumption seems to be satisfactory and normal. Hence, this Forum found that the case bears no merit. Accordingly, the case petition is hereby dismissed.

Accordingly, the case is disposed of.
