GIST OF THE CASE

Sri Santanu Ku Das, S/O Brusabhanu Das (Consumer) appeared in the hearing on Dt. 15.04.2025 at the camp held at ESO Office, Tileibani & filed the petition wherein he has raised objection about abnormal bills raised from Oct'2016 to Nov'2016. Hence, the complainant prayed before the Forum to resolve the billing dispute in an efficacious manner.

SUBMISSION OF OPPOSITE PARTY

The opposite party not submitted any relevant documents except billing abstract from May-2013 to Feb-2025 in this case.

OBSERVATION

The case is pursued with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4141-1518-0114, having CD-1.00KW under LT-Domestic category, coming under ESO-Tileibani & initial power supply effected on 17.04.2013. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- The ledger abstract revealed that actual bills were raised to the complainant from the
 date of power supply till Nov'2014. Nov'2014 bill was charged on actual basis
 considering the current reading of kwh "435", recorded in meter sl. no."8120565".

 Thereafter, provisional bills were raised from Jan'2015 to Sep'2016 @ 56 units on bimonthly basis.
- During Oct/Nov'2016, actual bill was charged with "2140" units, considering the advanced reading of kwh "2575" as recorded in aforementioned meter, thereby adjusting the provisional bills so raised from Jan'2015 to Sep'2016, amounting of Rs 1578.31/- for the month.
- Subsequently, actual bills were continued to charge thereafter from Nov'2016 onwards as per advanced meter reading recorded in meter sl. no."8120565".

After careful consideration of hearing, documents & statements available on records, the Forum is of the view that, the accumulated units of KWh '2575' so recorded in meter SI No "8120565" during Nov'2016 billing has been automatically adjusted in the same month. Hence, the energy bills so charged in Oct/Nov'2016 found to be genuinely raised as per advanced meter reading recorded in meter sl. no."8120565". Therefore, there is no further scope for revision of earlier bills.

Hence, the instant case petition is hereby dismissed.

Accordingly, the case is disposed of.
