## **GIST OF THE CASE**

Sri Jagannath Goel appeared in the hearing on Dt. 16.07.2025 at the camp held at SDO Office, Deogarh. The Complainant filed the petition disputed about the additional charge of Rs. 52000/- raised against his domestic connection. However, the complainant could not submit the period and nature of dispute raised. Hence, the Complainant prayed before the Forum to direct the Opposite Party to resolve the billing disputes accordingly.

## SUBMISSION OF OPPOSITE PARTY

The opposite party not submit any relevant except billing abstract from Marh-2019 to June-2025 in this case.

## **OBSERVATION**

The case is pursued with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4141-1402-1167, having CD-1KW under LT-Domestic category, coming under ESO-Deogarh & initial power supply effected on 28.08.2018. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- That, as per objection raised by the complainant and on examining the case in detail, the Forum observed from the records that provisional and average bills were charged from November-2020 to February-2024 on different units from time to time.
- The ledger abstract revealed that a new meter bearing SL. No-" WLT113116" was installed in the premises on 13-Mar-2024, replacing the old meter No."LW062540" and actual bills continued to charge thereafter till last billing.

President Grievance Redressal Forum TPWODL, Burla - 768017 3. It was observed from records that Rs. 49180.63/- was debited(added) to the consumer's account on the basis of defective meter assessment carried out by the Opposite Party for 730 days (i.e. 24 months period out the total 40 months defective period), effected in consumer ledger on 13-06-2025. This additional bill raised by the Opposite Party, reassessing the previous average bills on the basis of subsequent meter actual consumption recorded, is found to be genuinely charged as per regulations in force and hence, there is no further scope of revision of earlier bills.

The instant case is hereby dismissed.

Accordingly, the case is disposed of.
