OPPOSITE PARTY

GIST OF THE CASE

Sapan Saha appeared in the hearing on Dt. 18.07.2025 at the camp held at SDO Office, Brajrajnagar. The Complainant filed the petition disputed about wrong additional energy bills charged to the tune of Rs. 20000/-, against his domestic connection during February-2025 billing. Hence, the Complainant prayed before the Forum to direct the Opposite Party to waive out the energy bills charged during the above period & resolve the billing disputes accordingly.

SUBMISSION OF OPPOSITE PARTY

The opposite party has submitted ledger copy for the period from Aug'2004 to Jun'2025 in this case.

OBSERVATION

The case is pursued with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4171-2702-0189, having CD-2KW under LT-Domestic category, coming under ESO-Lamtibahal & initial power supply effected on 30.06.2004. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under,

- That, as per objection raised by the complainant and on examining the case in detail, the Forum observed from the records (FG & Samadhan App) that Rs. 20397.18/- was added(debited) to the consumer account on 09-02-2025.
- 2) That, August-2021 bill was charged on actual meter reading basis, considering the consumption recorded in meter No" WCS05022". Thereafter, average bills were raised from September-2021 to April-2023 on different units from time to time.
- 3) The ledger abstract revealed that a new smart meter bearing SL. No-"TPWODL1183306" was installed in the premises on 01-Jun-2023, replacing the old defective meter No." WCSo5022" and actual bills continued to charge thereafter till last billing.

4) It was observed from records that Rs. 20397.18/- that was debited(added) to the consumer's account, was due to the old defective meter assessment carried out by the Opposite Party on the basis of new meter actual monthly average consumption, so revised from September-2021 to April-2023, effected in consumer ledger on 09-02-2025. This additional bill raised by the Opposite Party, re-assessing the previous average bills on the basis of subsequent new meter actual consumption recorded, is found to be genuinely charged as per regulations in force and hence, there is no further scope of revision of earlier bills.

The instant case is hereby dismissed. Accordingly, the case is disposed of.
