

GIST OF THE CASE

Abhimanyu Luha, C/o Sibraj Luha (Consumer) appeared in the hearing on Dt. 07.08.2025 at the camp held at SDO-II Office, Jharsuguda. The Complainant filed the petition disputed about abnormal energy bills charged against his domestic connection during the year 2025 but could not emphatically submit the period and nature of billing dispute. Hence, the Complainant prayed before the Forum to direct the Opposite Party to resolve the billing disputes accordingly.

SUBMISSION OF OPPOSITE PARTY

The opposite party has not submitted any relevant documents in this case.

OBSERVATION

The case is pursued with all documents available on record and merit of the case. The complainant is an existing consumer of electricity under the operational area of TPWODL bearing consumer No 4135-2812-0042, having CD-1.50KW under LT-Domestic category, coming under ESO-Laikera & initial power supply effected on 29.11.2001. On scrutinizing the records in detail, the Forum observed the following facts which are envisaged here under that,

- 1) That, as per objection raised by the complainant and on examining the case in detail, the Forum observed from the available billing records (FG & Samadhan App) that first energy bill was raised in April-2002 on provisional basis, with meter No." 1008803" installed at site.
- 2) That, concerning to the period of objection averred by the complainant, it was observed from records that previous energy bills from February-2020 to April-2022 & from May-2022 to January-2023 were already revised by the Opposite Party. Rs. 3189.06/- & Rs.5322.72/- were credited (deducted from) back to the consumer account, effected in billing on 07-05-2025.
- 3) Thereafter, a new meter SL. No." TW02039439" was installed in the premises on 14-Feb-2023 & actual bills continued to charge till last billing.

The Forum on scrutinizing the records, reports available on record construed that necessary bill revision has been already carried out by the Opposite Party & the energy bills so charged particularly from February-2023 till date, was found to be legitimately raised as per advanced actual consumption recorded in meter SL. No." TW02039439".

In the absence of exact period & nature of billing dispute as filed by the complainant, the is hereby dropped.

Accordingly, the case is disposed of.

However, the complainant is at liberty to approach this Forum afresh with detailed petition & necessary supporting documents.
