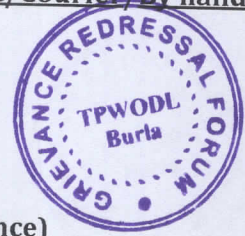

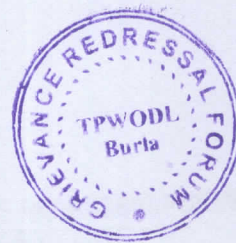



Hence the instance case petition is hereby dropped.


Accordingly, the case is disposed of.
